

## AUTHORISATION FOR THE TRANSPORT OF A MINOR WITHOUT ANY COMPANY

This authorisation will only be valid for the indicated service.

Children under the age of four should always travel accompanied by an adult, so the authorisation will only be valid if the minor is under the age of twelve but over the age of four. Children older than twelve won't need authorisation to travel.

The transport will be carried out under the full responsibility of the father, mother or legal guardian of the minor.

The authorisation should be signed by the parents or legal guardians of the minor and stamped by the entity owner of the service, otherwise it will be invalid. Before getting on the bus, it should be handed to the driver the copy of the authorisation (signed by the parents or legal guardians and stamped by the company) and the documentation which identifies the minor should also be showed to the driver.

Personal data included in the present authorisation will be handled with the purpose of managing the transport of unaccompanied minors, destroying them 24 hours after the arrival of the service to the destination. In spite of this, the father, mother or legal guardian of the minor are expressly informed that they may exercise the rights of access, rectification, cancellation and opposition in accordance with the Data Protection Spanish Act and other regulations applicable to the effect, by sending a duly signed request to the following e-mail address: [info@monbus.es](mailto:info@monbus.es), or by sending a written request to the following address: C/ Cotón de Arriba nº2, Polígono A Louzaneta, 27297 LUGO (the letter should be addressed to TIC department), attaching in both cases a copy of the DNI or passport.
